2) Composition / Information on Ingredients

Products consisting of synthetic organic polymers in the form of dispersion in water together with organic additives not classified as hazardous.

3) Hazard Identification

Hazard designation : Not classified under the current regulations.

4) First Aid Measures

No special measures required.

After inhalation : Supply fresh airs, if persistent symptoms develop seek medical attention.

Skin contact : Wash off before dispersion dries, using soap and water if necessary.

Eye contact : Rinse opened eye for several minutes under running water. Seek medical attention if symptoms develop.
